## **Pricing + Payment**

\$2,250 USD for a shared (2 person) room to \$2,500 USD for a private room. Each room has a private bath and air-conditioning. Private rooms have king-sized beds. If you are booking with someone you know and would like to share a king size bed, we can give you the shared room rate.

Deposit is \$800 and will be accepted from now until August 1, 2023, and are non-refundable, but are transferable. The balance is due by October 1, 2024.

Open to guests identifying as female.

### **Price Includes:**

- Lodging for 6 nights/5 days
- Shuttle transportation from Mérida airport (MID) on October 22
- Return transportation to MID on Oct 28
- Participation in all group activities
- All art materials needed for creative activities
- 3 meals per day (vegan and vegetarian options)
- Coffee, tea, juices, water, and fruits
- Use of kitchen, common areas, pool, and rooftop
- One-hour massage

#### Price does not include:

- Flights to Mérida (approximately \$450 \$700 RT)
- Drinks/food at local restaurants
- Some excursions
- Tip for staff (\$50 USD/guest)
- Personal groceries

### Cancellations + Refunds

If a Participant wishes to cancel their booking, they must notify *Colores Retreats*, in writing, 60 days prior to departure. If a deposit has been made it cannot be refunded but can be applied to a future retreat or transferred to another Participant. If full payment has been made, all but the \$800 deposit will be refunded. If Participant cancels after August 22, no refund will be issued.

If any outstanding payment is not received by October 1, 2023 *Colores Retreats* reserves the right to cancel participation without a refund.

If, for any reason, a Participant leaves the retreat once it has commenced, *Colores Retreats* is not obliged to issue any refund, credit, or compensation.

If *Colores Retreats* is forced to cancel or significantly alter your trip, we will notify the Participants in writing as soon as possible. When a tour is cancelled for foreseeable reasons, *Colores Retreats* will provide the option for a full refund or full credit of trip payments made. This refund or credit will constitute full settlement of any claims the Participants may have against *Colores Retreats* or our suppliers.

Colores Retreats reserves the right to cancel any workshop/activity at any time for any reason, including if there are too few Participants, or if the quality of the trip or the safety of travelers is judged by Colores Retreats to be compromised. Refunds will not be issued for individual activities in the trip itinerary.

**Passport Validity:** To enter Mexico, your passport must be valid for at least 90 days following your departure date. You must also have at least one blank page in your passport.

**Participant Information:** Each person must provide (1) their full name as it appears in their passport, (2) their passport number and issue/expiration date, (3) their date of birth, (4) nationality, (5) any and all allergies (food or otherwise), (6) dietary preferences, (7) flight itinerary, and (8) any and all pre-existing medical conditions regardless of severity or duration of such condition. The foregoing information must be submitted *no later than two weeks* prior to departure.
